SIS, GIPE trade charges again as they fight over funds, bank account

THE STRAINED relations between the Servants of India Society (SIS) and its institute Gokhale Institute of Politics and Economics (GIPE) is once again out in the open with both the bodies trading charges of wrongdoing against each other. While addressing the media in Pune on Thursday, Vishal Gaikwad, officiating deputy registrar of GIPE accused the SIS of freezing the

bank accounts of the institute. On his part Damodar Sahoo, chairman of SIS, claimed that GIPE had unilaterally converted the jointly held bank account of the institute to a single-operated one which had prompted SIS to write the bank.

Gaikwad said, as per University Grants Commission (UGC) norms, the sponsoring society does not have rights over the bank accounts of the institute.

"We learnt from the banks that our accounts were frozen.

We managed to get them unfrozen but this is a gross violation of rules," he claimed. Gaikwad said they have written to the Deccan Police to include the name of Sahoo in the ongoing case of allegedly fraudulently transferring Rs 1.42 crore from GIPE for the use of SIS.

"We have also written to the charity commissioner asking for the present board of SIS to be dismissed and appointment of a neutral observer in its place," he said.

Relations between SIS and

GIPE have soured since the last year with both the bodies trading charges against each other. GIPE's chancellor Sanjeev Sanyal had made serious allegations against Sahoo and others of misappropriating funds. Sanyal was swiftly removed from his position by Sahoo but was reinstated. Milind Deshmukh, the secretary of the SIS was arrested by the Deccan Police for his role in the multi-crore corruption scandal that had rocked the institute. Deshmukh was later removed from his position and is out on

bail now.

Sahoo on his part claimed that GIPE had unilaterally deviated from the convention of jointly operated accounts which had prompted the SIS to write to the bank.

"The GIPE had not intimidated of the conversion of the account to single operated," he said. Asked about the formation of an advisory committee which Gaikwad had termed as illegal, Sahoo said the committee was for better coordination between both the bodies.

5 juveniles try to kill minor for refusing to clean bathroom at observation home, say police

FIVE JUVENILES in conflict with the law allegedly attacked and attempted to kill a 17-year-old boy on the premises of the government-run Pandit Jawaharlal Nehru Udyog Kendra, an observation home located at Yerawada.

According to the police, the accused attacked the 17-year-old because he refused to clean a bathroom on the premises. The incident took place at barrack No. 2 of the observation home around 9.15 pm on Tuesday.

The observation home authorities reported the incident to the Pune city police. Subsequently, an FIR was lodged at the Yerawada police station against the five minors under Bharatiya Nyaya Sanhita (BNS) sections 109 (attempt to murder), 115(2) (voluntarily causing hurt), 352 (intentional insult with intent to provoke breach of peace), 351(2) (criminal intimidation), 3(5) (criminal act done by several persons in furtherance of common intention of all).

Assistant police inspector Vishal Takle, the investigation officer of the case, said the five accused are lodged in the observation home after they were booked in separate criminal offences lodged at different police stations in Pune in the past.

Police sources said after the victim refused to clean the bathroom, the accused boys allegedly tore a piece of towel and tried to strangle him, the FIR stated.

After receiving information, observation home staff and authorities rushed to the spot and rescued the victim. "The victim was taken to hospital for treatment. He was discharged on

Wednesday. We have sought the documents and other details pertaining to this case from the observation home. Further probe is on," said Takle.

The observation home was established by the British in 1889 as 'Reformatory School Yeravada, Poona'. It was redesignated as 'Yeravada Industrial School Poona' from 1936 to 1989. In February 1990, it was further redesignated as Pandit Jawaharlal Nehru Udyog Kendra and turned into a care home for destitute children and in 2009 it became an observation home for juveniles in conflict with law.

In August 2022, stone pelting was reported on the premises, following a quarrel that started when some juveniles were playing football. Also, multiple incidents of minors escaping from the home have been reported in the past.

Steel rods kill truck driver as he applies sudden brakes

Pune: A trailer truck driver was killed in Pune on Thursday after steel rods loaded in the vehicle pierced through the cabin when brakes were applied suddenly and impaled him, police said.

The incident took place at 8:30 pm near Chandni Chowk on Satara lane of Mumbai-Bengaluru Highway, an official said.

"The trailer truck was loaded with steel rods. When he applied brakes suddenly, the rods moved towards the front of the vehicle, crashed through the driver's cabin and impaled him. The vehicle was removed with the help of a crane by fire brigade personnel," the Bavdhan police station official said.

Pune reports 48 new Covid cases, 4 cases from Pimpri Chinchwad

PUNE REPORTED 62 new Covid 19 cases on Thursday, of which 48 were from the city, four from Pimpri Chinchwad and 10 from Pune rural area.

As per state health department data, a total of 112 new Covid cases were reported.

The state has conducted a to-

tal of 19,772 Covid tests since January 2025 of which 1,812 patients are confirmed positive with the infection.

Till today 1,162 patients have recovered.

State health department officials said that patients had mild symptoms. Since January 2025 till date, a total 21 patients who had tested positive for Covid 19 died and majority had comorbid health conditions.
